Be it enacted by the Oireachtas as follows:

Definition

1. In this Act "Principal Act" refers to the Broadcasting Act 2009.

Amendment of section 109 of the Principal Act

- 2. Section 109 of the Principal Act is amended—
 - (a) in subsection (3), by the deletion of the following:

(b) in subsection (4), by the deletion of the following:

"the auditors appointed by the board of RTÉ under paragraph (a) of subsection (3) or".

Amendment of First Schedule to Comptroller and Auditor General (Amendment) Act 1993

3. The First Schedule to the Comptroller and Auditor General (Amendment) Act 1993 is amended by the insertion of "Radio Telefís Éireann".

Amendment of Second Schedule to Comptroller and Auditor General (Amendment) Act 25 1993

4. The Second Schedule of the Comptroller and Auditor General (Amendment) Act 1993 is amended by the deletion of "Radio Telefis Éireann".

Short title, collective citation and commencement

- 5. (1) This Act may be cited as the Broadcasting (Oversight of RTÉ Accounts) (Amendment) Act 2024.
 - (2) The Broadcasting Act 2009 and this Act may be cited together as the Broadcasting Acts 2009 and 2024.
