PQ Question: To ask the Minister for Health for an update on waiting lists for adult ADHD services, per CHO, in tabular form; what efforts are being taken to reduce these waiting times; if those in catchment areas without adult ADHD services in place can access services in surrounding CHO areas; and if he will make a statement on the matter. -Mark Ward

Dear Deputy Ward,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The waiting lists together with other relevant data on staffing and clinical activity is shown in the table below.

The waiting times vary from just under one year to up to 4 years. Efforts taken to reduce these waiting times are:

- 1. Funding of €106,000 allocated to CHO6 for a waiting list iniative. The service was unable to recruit the staff for this unfortunately.
- 2. The very recent introduction of GP referral forms in CHOs 1,3,6 to both inform GPs who is likely to benefit from referral to these specialist services and also to assist services in more efficient triage of referrals. CHO4 Cork had introduced a GP referral form when it started in April 2023.
- 3. The Clinical Lead is developing a stepped care approach. This is well established with ADHD Ireland. A proposal has been submitted to HSE Disability Strategy to develop a Neurodiversity Hub in each CHO so GPs can refer to this hub in the first instance for assessment of possible ADHD together with consideration of whether other neurodiversive conditions such as Autistic Spectrum Disorder (ASD) are present. It is envisaged that those with milder ADHD will have their needs met by a combination of this Hub response and ADHD Ireland. It will also ensure those who are autistic are not by default referred to the Adult ADHD Services because of the current absence of a response at Disability/ Primary Care level.

Given these waiting times and the significant unmet need which is a consequence of no public ADHD Services for Adults in Ireland, there is no capacity to accept referrals from areas currently not funded by the Department of Health for an Adult ADHD Service.
